Dear family and friends of Sunrise:

In order for Sunrise to conduct visiting, we must be sure all visitors are adhering to the Core Principles of COVID-19 Infection Prevention, as noted in the Center for Medicare and Medicaid Services' regulation (listed in the Revised March 10, 2021 CMS Nursing Home Visitation QSO-20-39-NH and posted on <https://sunriseretirement.com/covid-19-update/>). These principles are incorporated into the policy that Sunrise has developed below. We ask for our visitor's active participation with the policy so that we are able to provide all of our residents with this life enriching opportunity.

(Policy Updated as of March 11, 2021)

SUNRISE VISITING POLICY (NURSING FACILITY)

- Visiting will be by appointment only
 - Appointments will be made from 9am – 5:30pm, Tuesday through Friday, with visiting hours ending at 6:30pm
 - Appointments can be made for weekends, as available
- COVID testing will be offered on MONDAYS from 3-5:30pm
 - Testing is encouraged, especially for visitors who have not received full vaccinations, in order to help us prevent the spread of COVID in the nursing facility
- Visitors will be required to check in/out at the front desk, answer screening questions and have their temperature recorded, and perform hand hygiene prior to entering the resident's neighborhood
- Visitors will be required to wear face masks and eye protection at all times during their visit and maintain social distancing
 - Guests who have been vaccinated will not be required to wear face shields
 - Guests who have been vaccinated are also allowed to "touch" (hug, hold hands, etc.) their loved ones, per the CMS regulation, as long as they perform hand hygiene before and after
 - Vaccinated means a full two weeks has passed since the 2nd shot of a 2 shot vaccine or 2 weeks after a single shot vaccine
- Visitors will be required to stay in the resident's room during their visit and will not be allowed to move about the neighborhood
- Compassionate care visits can be made with Activities but will not be required to adhere to visiting hours if there is an urgent situation

VISITING PLANS FOR FOUNTAIN VIEW ASSISTED LIVING

The Visiting Plan for Fountain View Assisted Living will be similar to that of the nursing facility (above).

- Visits will be by appointment only, including compassionate care visits. Appointments will be made for Tuesday through Friday.

- Visitors will be encouraged to test prior to visiting, in order to prevent spreading COVID to the Assisted Living residents
- Visitors will be required to check in and out, wear appropriate PPE (masks), perform hand hygiene as required, and maintain social distancing
- Visitors will be required to stay in the resident's room during their visit and will not be allowed to move about the neighborhood

Appointments can be made with the Activities Department by calling 276-3821 x3130. If you don't get a response to a message left about scheduling an appointment, please check with the receptionist prior to coming for the visit to be sure we can accommodate the visit at that time.
